**1. Everyday Bordering as a New Citizenship Duty - 08 May 4-5:30pm, IOE-UCL:** Prof. Nira Yuval-Davis (UEL) discusses the construction of unpaid/untrained border guarding as a new everyday citizenship duty. This construction has been part of the more systemic crisis of governability under neo-liberal globalisation as well as an attempt to respond to growing autochthonic populist political projects of belonging. The illustrative examples in this paper are taken for the EU funded EUBorderscapes project and fieldwork in London during the implementation of recent UK Immigration Acts. **2. IAS Talking Points: Trauma or lack of love? Between Measuring and Listening to Post-Trafficking Suffering - 09 May 6-8pm, IAS Common ground, UCL:** In this talk, Dr Runa Lazzarino will explore the issue of the psychological condition of victims of human trafficking (VoTs) combining an anthropological approach with biomedical studies. **3. Europe's Refugee Crisis: Humanitarian complicity in abuse? With special guest Dr Xand van Tulleken - 12 May, 6:30-9pm, Cruciform Lecture Theatre:** In 2016 Dr Xand van Tulleken made a documentary for BBC1 examining the European migration crisis. The European camps, particularly in France, were among the worst he has ever seen. They highlighted the extreme limits of aid delivered in camps as a response to massive displacement. His talk will discuss the humanitarian response in Lesbos, Berlin and Calais and the nature of refugee camps more generally. Drinks and canapés will follow the talk. **4. Refugee and Asylum Workshop with Professor James Hathaway, 15 May 1-5pm:** Professor James Hathaway will lead a workshop with PhD students investigating questions relating to refuge and asylum. The workshop will provide an opportunity for PhD researchers to discuss issues relating to the use and application of international refugee law and to bring together researchers with an interest in refugees and asylum-seekers to learn from each other and to think about each other's work from a variety of perspectives.
